



Softan® Finition

Softan® Finition contributes to the roundness and harmonizes the structure in mouth thanks to its specific formulation.



PRODUCT CHARACTERISTICS

- ◆ **Formulation:** Preparation made with tannins extracted from oak and vegetal polysaccharides, instantaneously soluble.
- ◆ **Enological benefits :** Softan® Finition helps to **reveal aromas** in white, rosé and red wines. Used before bottling, it provides **roundness** to wines and improves their **length** on the palate.



DIRECTIONS FOR USE

- ◆ Dissolve in 10 times its weight of wine, then add into the tank during a pump over or during a transfer in order to obtain a perfect homogenization. Softan® Finition should be used during aging, to be added before the last filtration step. Earlier addition is appropriate to benefit from the effects on colour stabilisation.
- ◆ **Dosage:** *White and rosé wines:* 1 to 3 g/hL. *Red wines:* 10 to 40 g/hL.
The dosage of tannins depends of each type of wine and winemaking imperatives to be achieved. Preliminary tests are necessary to comply with the oenological codex (OIV).
Impact on filtration: Softan® Finition contains protective colloids which may influence filtration. Optimum filterability should be ensured before addition. On wines with a CFLA < 10, the product can be added up to 48 hours before bottling.
Lamothe-Abiet provides single-dose samples (for one bottle) to simplify the calculation of the treatment.
Maximum legal dosage (EU regulation): 60 g/hL.

- ◆ Bags of 1 kg (in 10 kg box) or 4 bags of 250 g (in 1 kg box).
- ◆ Store in its original packaging hermetically sealed, in a cool and dry place without odors. Respect the optimal date of use written on packaging. Use quickly after opening.
